I. CALL TO ORDER: Erica Williams, Chair

The meeting began at 7:05 pm.

II. ROLL CALL: Aisha Harris, Deputy City Clerk

Ahli Moore was absent.

III. Recognition of Resolution of Creation

Chair Erica Williams read the recognition of the Transportation Advisory Committee.

IV. PUBLIC COMMENTS:

- Overall limit for public comments is 20 minutes. Limited to 2 minutes per speaker.
- Speakers can only speak once in public comments. Public comments are restricted to topics regarding transportation projects serving Stonecrest.

One (1) Public Comment was read from Dave Marcus regarding walkability and bicycle friendliness.

V. AGENDA: The Members introduced themselves before they reviewed the agenda items.

A guest, Mr. Kelly Jordan, recommended that the Transportation Advisory Committee makes a sub-committee that would focus on the multi-use trail plan that would focus on the City. The hope for this plan would be that the trail would extend out and connect other parts of the City.

b. Suggested meeting schedule

Mayor Pro Tem George Turner offered suggestions for assignments, such as someone reporting on heavy rail and MARTA as it relates to South DeKalb. In addition, someone should keep track of the light rail and bus rapid transit movements in Stonecrest and other mobility strategies. Kendra Price, Kelly Jordan, and Calvin Lawrence offered to be on the trail study and discuss next steps.

d. Offer of assignments

Motion 1 - Made by Mayor Pro Tem George Turner to establish a subcommittee composed of Ms. Kendra Price, Mr. Calvin Lawrence, and Mr. Alan Burnette. Seconded by Councilmember Tammy Grimes. **Motion passed unanimously.** Chair Erica Williams asked Kendra Price to Chair the sub-committee.

Motion 2 – Made by Mayor Pro Tem George Turner to establish a Freight Cluster Study Committee composed of Mr. Bernard Knight, Mr. JW Eady, and Mr. Alan Burnette, with Mr. Knight as Chair. Seconded by Alan Burnette. **Motion passed unanimously.**

e. Comments

Mayor Pro Tem George Turner stated that officers will need to be elected.

Chair Erica Williams wants to start conversations regarding sidewalks, particularly on Covington Highway
