STANDING ORDER OF THE COURT REGARDING THE CONVERSION OF FINES AND/OR FEES TO COMMUNITY SERVICE HOURS AND CREDITING OF COMMUNITY SERVICE FOR OTHER ACTIVITIES

Where a defendant has been sentenced to pay fines or supervision fees as a condition of probation, the fines and/or fees may be converted to community service hours in cases where the Professional Probation Services has determined that the defendant is financially unable to pay the fines and/or fees.

Fines and/or fees shall only be converted to community service hours in cases where it would prove a financial hardship for the person to pay. Such a determination to convert fines and/or fees to community service hours shall only be made by Professional Probation Services after a full financial assessment shows that the person is unable to pay.

Such a determination shall also only be made in cases where the particular probationer has no outstanding violations of probation pending before the Court.

Professional Probation Services Rules and Regulations shall determine the means and processes of the financial assessment.

In those cases where a financial assessment shows the probationer is unable to pay the fines and/or fees as ordered, the amount shall be converted as follows: Every \$15 of the fines and/or fees amount shall be converted to 1 hour of community service.

Attendance of any approved meeting or program will be an acceptable form of community service, so long as the attendance can be verified by Professional Probation Service. In cases of physical hardship, Professional Probation Service may approve courtroom observation as an acceptable form of community service and community service donations.
